## "Festival of Art" TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this competition is deemed acceptance of these Terms and Conditions.
- The promoter is The Trustee for KAHI Phoenix Trust trading as Phoenix Shopping Centre (ABN 30 914 308 757) of 254 Rockingham Road, Spearwood WA 6163 AUSTRALIA 08 9418 1655 ("Promoter").
- 3. Only residents of Western Australia are eligible for the Competition.
- 4. Entrants must have been born between 13 June 2005 and 12 June 2019.
- 5. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition.
- 6. Employees (and their immediate families) of the Promoter, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter. - 10. The artwork submitted must be original and have been completed after 1 July 2023.
- 11. Any works submitted after the delivery deadline of Monday, 17 June 2024 between 2pm 6pm will not be included in the exhibition.
- 12. All works must be collected on Monday 1 June 2024 between 2pm 6pm. Work left uncollected after Tuesday 2 July 2024 will be disposed of.
- 13. 2D work must not exceed 100cm x 100cm.
- 14. 3D work must not exceed 60cm x 60cm x 60cm.
- 15. Artwork that exceed the size requirements will not be accepted.
- 16. All artworks must be dry/sprayed with fixative before drop off.

- 17. Entries can be framed or unframed. Unframed artworks will be mounted by a method of the curator's choice. Artworks must have appropriate hanging equipment, i.e. D rings, attached prior to drop off. Framed artworks should have suitable hanging devices (D rings with nylon poly cord). Please no sawtooth hangers.
- 18. All works must be deemed appropriate to be exhibited at a family exhibition. The organiser retains the right to deem any works unsuitable and therefore not eligible to be displayed.
- 19. All care will be taken with artworks. However the Promoter will not take responsibility for any damaged or stolen artwork.
- 20. The Promoter reserves the right to use photographs taken of entries and entrants for promotional purposes.
- 21. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
