

“Social Media Competition”
TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this competition is deemed acceptance of these Terms and Conditions.
2. The promoter is The Trustee for KAHl Phoenix Trust trading as Phoenix Shopping Centre (ABN 30 914 308 757) of 254 Rockingham Road, Spearwood WA 6163 AUSTRALIA 08 9418 1655 (“**Promoter**”).
3. Entry is only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, tenants and their employees, and agencies associated with this promotion are ineligible to enter the major prize draw.
